What are the Kirkpatrick® Certifications?

For years, Kirkpatrick Partners has certified professionals around the world, either directly or through their affiliate channel partners, in the Kirkpatrick Four Levels® of Evaluation. Professionals earned Bronze, Silver, Strategic Evaluation Planning, and Gold certifications.

The certifications became a must have for professionals in talent management, evaluation, measurement, and data. The certifications gave practitioners the opportunity to have a renowned name in the learning and development industry back their skills, earn more through career advancement, align the organization to the business to achieve the coveted “seat at the table,” and access jobs unavailable to non-certified professionals.

Since 2024, Kirkpatrick Partners has worked to revamp the current certifications including merging Strategic Evaluation Planning and Silver, as well as renaming the certifications to align them to job roles and skills, and introducing new certifications such as a Performance Designer certification to teach instructional design using the Kirkpatrick Model as a framework, and a Learning and Performance Manager certification for managers of professionals who execute the evaluation efforts at their organization.

This work is our way to bring performance to the forefront and align the learning function with the business so that learning can make data driven decisions and develop their own chain of evidence to demonstrate their value.


Importance of Recertification – to Monitor and Adjust

As the Kirkpatrick Four Levels® continues to grow throughout the world, the world of work changes, competencies and skills evolve, technology advances, and there is more demand to demonstrate the value of learning initiatives than ever before, we have worked to refine the model, our approach, and our programs. Therefore, it became apparent that to maintain the integrity of the certification, and to provide an opportunity to monitor, support, and adjust, we must introduce recertification as part of our certification process.

Certification holders are not required to recertify, however those who choose not to will be in inactive status. You will still be recognized as someone who completed the certification and hold your certificate. Those who choose to recertify will be in Active status. Professionals who hold their certification in Active status will be able to have their credentials verified through our credentialing system and receive special perks and exclusive events for our Active professionals.

Recertification Process

KIRKPATRICK CERTIFICATION PROCESS



Kirkpatrick Certifications will be valid for 3 years. You will receive notifications of the expiration of your certificate to give you time to earn and apply for recertification to avoid any lapses in certification.

If you hold Bronze and Silver certifications, you will recertify to Silver when that time comes, your Bronze expiration date will match Silver.

If you have other certifications, they will expire individually, and you will need to resubmit an application for each certification you hold.

You will be able to use the same points for the multiple recertifications and just complete an updated report for that specific certification.

Recertification Requirements

To recertify, you will be required to accumulate 30 points in the form of any combination of the following: continuing education, speaking, publishing, and Kirkpatrick community membership.

- Analysis Presentation/Report (Silver/Analyst only)

Cost to Recertify

To process your certification, the fee is \$295. If you are recertifying for Bronze and Silver, the fee is \$490 and you will receive both certifications.

Lapse in Certification

Kirkpatrick® Certified Professionals must recertify every 3 years. If they do not, that certification will be null 30 days after the expiration date.

If a Kirkpatrick® Certified Professional does not recertify, they will need to go through the certification process again for that certification.

Frequently Asked Questions

1. I was certified by an affiliate; do I still need to recertify?

- a. Yes, you are still required to recertify. You are able to use courses, programs, and webinars that are being held by an affiliate partner of Kirkpatrick Partners towards your continuing education points.

2. I was certified before 2025, what is my expiration date?

- a. Please use the following chart to identify your expiration date:

3. I am Gold certified do I need to recertify as Gold?

- a. No, you do not. However, we would love for you to continue sharing your Kirkpatrick success stories and invite you to join a Kirkpatrick podcast episode or apply to be a speaker at the Kirkpatrick Summit. You will however receive a badge labeled Champion to align with our new certification titles.

4. I am Kirkpatrick Strategic Evaluation Planning certified. Will I lose that certification?

- a. No. Since that program has been merged into the Analyst (Silver) program, you will not lose that certification.

5. I was told my certification was indefinite.

- a. To preserve the integrity of the certification programs, the Kirkpatrick Four Levels® model and methodology, and ensure we are keeping up to date with learning and performance and evaluation, similar to other industry associations such as ATD, we have moved to a maintenance model. It allows us to practice our favorite part of the model: monitor and adjust.

Our goal with recertification is truly to help ensure you are continuing your education, keeping up your evaluation skills, and gives us a chance to provide feedback, as well as learn more of how we can better support you. Additionally, it ensures we continue to grow and evolve to ensure the Kirkpatrick Model remains the industry standard for evaluation through our continuous evaluation and improvement of the model.

As a reminder, you are still recognized as having gone through our certification program, however, will show as inactive.

6. I have a lot of people that need to be recertified.

- a. We appreciate the trust you have placed in Kirkpatrick Partners and value in our certification program. We do not want recertification to be a burden, so please contact Kirkpatrick Partners to discuss your case individually so we can work together on a plan to recertify your team.
